RRT III ACTIVATION DRILL REPORT-OUT

- On April 24, 2018, an Incident-Specific RRT III Activation Drill was conducted.
- The exercise started at 0800 when the EPA RRT Coordinator sent a text message and an email to all the RRT III Standing Member Agencies requesting them to report via conference call at 1000.
- The text message advised them to look at their emails, where they would find information about the scenario.
- Both messages (text and email) were sent to all the primary and alternate contacts.

RRT III ACTIVATION DRILL REPORT-OUT (CONT)

- The scenario was the instantaneous release of an estimated 1,000,000 gallons of a medium crude oil.
- > At 1000, an Incident Specific RRTIII Activation call was conducted.
- After the scenario was discussed and questions about it were addressed, the EPA RRT Coordinator listed the federal agencies and states and commonwealths required to participate, and excused the other agencies from the rest of the exercise.
- Participating agencies were selected based on the spill trajectory and/or the potentially impacted resources.

RRT III ACTIVATION DRILL REPORT-OUT (CONT)

- > Participating agencies were requested to provide the following information before 1400:
 - 1. POC for Natural Resource Trustee decision-makers (name, address, email, phone number)
 - 2. Internal chain of command
 - 3. Name of person with decision authority within their agency for the use of chemical countermeasures
 - 4. Additional information needed to make a decision on the use of dispersants
 - 5. Recommendations and BMPs for the scenario
 - 6. Can decision-making be provided within 4-hr response window?
- The exercise concluded at 1400, when the participating agencies were required to provide the information listed above.

RRT III ACTIVATION DRILL LESSONS LEARNED

> Participation improved from the last time we had an RRT Activation Exercise.

 \geq Most of the feedback was provided within the 4 hours as requested.

 \succ Most agencies were clear on who were the primary and alternate contacts.

 \succ Some contacts had changed and needed to be updated.
