USCG Delaware Bay, FOSC Report – Dec 2024

Notable Cases / Events

- 29 May 24, Delaware City Refining discharged 20+ barrels of Hibernia Crude Oil into the Delaware River due to a gasket failure in their pipeline. Discharge contained to marshlands and mudflats. Novel recovery methods used.
- 12 Sep 24, the Tank Barge DOUBLE SKIN 59 discharged 65 barrels of fuel oil (RMG38) into the Christina River, DE.

- 7 Oct: S/V MIST OF AVALON sank at the Cambridge Yacht Maintenance Marina with over 1,800 gals of oily water mixture onboard.

- Best Practices:

- Challenge: OSRO interest to participate in GIUEs has decreased significantly causing numerous GIUE failures last FY.

Notable Cases / Events

- M/V DALI: The M/V DALI completed salvage and HAZMAT removal operations in SEC VA's AOR on 19 September. This three-month response effort resulted in the safe removal of an estimated 117,000 gallons of hazardous liquids.
- **29** August **02** September 2024: SEC VA opened a federal project and hired an OSRO to remove 350 gallons of gasoline from a sunken 32-foot sport fisher discharging gasoline in Portsmouth, VA.
- **26 September 2024:** NOAA Satellite imagery detected a seven-mile sheen off the coast of Virginia in the Atlantic Ocean. SEC VA and D5 Intel located the suspected vessel and passed the case to SEC MD-NCR for enforcement action.

Best Practices / Lessons Learned / Challenges

- Creative response strategies such as using corrugated piping to act as secondary containment around hoses transferring hazardous liquids over the water is a cost-effective way to minimize releases caused by hose rupture.
- Interagency coordination between regional Coast Guard units, neighboring Sectors, and partner agencies is vital to successful preliminary investigations and enforcement action, as was demonstrated in the NOAA satellite imagery case.
- Challenges: Commercial Offshore Wind Farm development ~25 NM offshore; Spaceport Authority increased activity projection (launch rate will double in the next four years by FAA projections).




- CAPT Aaron Demo, Deputy Sector Commander and CDR Holly Deal, Response Department Head, reported to Sector Virginia summer 2024.



Notable Cases / Events

- IMD responded to 32 National Response Center Reports since 01 April 2024; The efforts resulted in 02 Letters of Warning and 02 NOVs issued to the responsible parties.
- June 27th five one-ton storage sacks (supersacks) containing trichloroisocyanuric acid (TCCA) were exposed to rainwater at the American Distillation Inc., (ADI) facility in Leland, NC. However, this was not discovered until June 29th. Sector NC assumed OSC and initiated ICP.
- USACE began initial/emergency remediation actions at Buxton Formerly Used Defense Sites (FUDS) on September 20th.

Best Practices / Lessons Learned / Challenges

- American Distillation Inc TCCA Case:
 - No initial NRC Report made by RP, which delayed response actions; also delayed notification from partners.
 - Early communications w/EPA on OSC authorities. On July 2nd, three days after initial notification, Sector NC transferred OSC authority to EPA Region IV, due to their expertise and current management of this case. Outstanding support from EPA.
 - Required ADI submit a site safety and health plan and a plan on how to properly mitigate and dispose of the product. Early communications on this prevented further delaying mitigation efforts.

Exercises / Training

- Supported the CG's FOSCR performance Qualification Standard (PQS) revision workshop held from August 19-23, 2024.
- Planned and hosted Hurricane Preparedness Week in conjunction with D5 HURREX TTX.
- Participated as key members in the Quarterly Clean Land & Harbor port stakeholder meeting provided key updates and fostered stakeholder coordination.
- Environmental Response Investigator College being held on December 03-05, 2024 at Sector NC.

- LCDR Brian Waters reported in as new Incident Management Division (IMD) Chief on July 7th.
- Establishment of Short-Range Unmanned Aircraft Systems (SR-UAS) Program with acquisition of SEC NC's first Parrot Anafi SR-UAS.

Notable Cases / Events

- 14 October 2024 ITV Robert Dean Moore: Approximately two gallons of diesel was discharged into the Ohio River due to operator error. During refueling, the PIC opened a valve to a full tank which resulted in the discharge.
- Fall/Winter 2024 Elizabeth Dam Demolition Demolition continues. The channel is currently 100 feet wide and will be widened to 200 feet (early December). Once dredging/clearing of debris is complete, the channel will be widened to 300 feet (goal of mid-December).

Best Practices / Lessons Learned / Challenges

- **BP** Utilizing multiple personnel from varying specialties prompts decisive action, presents a uniform expectation of mariners and their Companies, effectively resolving and ultimately preventing discharges of oil into the Western Rivers.
- LL/C During a recent GIUEs, MSU learned that the facility's transfer area can be difficult to access with large vacuum trucks due to steep hills and tight turns. This facility will now request a smaller vacuum truck for any further exercises/real world responses to ensure adequate access to the spill site can be obtained.

Notable Cases / Events

- JAN 2018: GATE CITY sank while docked on the Big Sandy River. On Dec 4, 2024, the Dep of Justice, U.S. Attorney's Office, Charleston, WV formally recognized four active duty and two civilian U.S. Coast Guard members, and one WV DEP member with the U.S. Attorney's "Award for Excellence in Pursuit of Justice".
- FEB 2024: ITV TOM FRAZIER ran aground on the Ohio River and began taking on water in forward hull. Sheen observed from dewatering pumps.

Best Practices / Lessons Learned / Challenges

• During the GATE CITY pollution case in 2018, municipal water intakes secured for long periods. The city of Kenova, WV required public drinking water supplies be trucked in by the state of West Virginia.

- Our new Commanding Officer, Commander (CDR) Christopher Weiser reported in June.
- Due to staffing shortages throughout the Coast Guard, all personnel stationed at our boathouse, Detached Duty Huntington, have been reassigned to other areas along with the small response boats.
