ECRM 2 Desired Outcomes

- Evaluate various methods of assorting facilities (federal and state collaboration)
- Develop a method for ranking facility chemical risk
- Formulate an "all hazards" understanding of risk throughout the region
- Determine a process for assigning relative risk levels to facilities of greatest concern

ECRM 2 Desired Outcomes

- Processes for collecting, storing, and using facility information
- Ensure that local responders have access to key information in a format that is useful to identify and respond to risks at chemical facilities
- Determine methods for getting chemical safety and security information, and effective outreach, to stakeholders

- Assessment of individual agency points of view of the usefulness/effectiveness of a joint inspection process
- Framework for scheduling, executing, and reporting a joint inspection

ECRM 2 Work Product – Development

- LEPC Guide to High Risk Chemical Facilities.
 - Help LEPCs to do three things:
 - Develop and maintain an inventory of high risk facilities in their jurisdiction;
 - Prepare for an incident at a high risk facility;
 - How to/not to respond to an incident at a high risk facility.
 - Help LEPCs get assistance from federal/state/county experts who can help with questions and challenges in all three parts.

ECRM 2 Work Product – Development

Multi-Agency Guide to Inspecting High Risk Chemical Facilities.

Develop an "awareness" guide where agencies identify priority issues that present risks to public health and the environment from high risk facilities. This could result in a manageable short list of key things to look for that other agencies key on. Inspectors can share and refer observed key issues so that the responsible agency can follow-up.

ECRM 2 Work Product - Realized

 - Other agency observers attend the inspection
 - Training and awareness goal
 - Sustainability given current resources
